7. One more classroom must be equipped with smart Board.
8. Fire Alarm System be installed properly/auditorium has obstruction of fire hose in between of passage be rectified.
9. Medical leave should be as per university rules.
10. Summer / winter vacation should be followed as per university norms.
11. Salary structure for faculty should be as per UGC norms.
12. More faculty should encouraged for more National / International workshops / conferences / seminars.

The institution / society shall follow the fee structure prescribed by the University / Govt. of NCT of Delhi (**State Fee Regulatory Committee**) and will not charge any unauthorized additional fee or any advance fee for the next session. It will also be ensured that security deposits of students and their original certificates are returned back in appropriate manner and within stipulated time. No extra fee shall be charged for the book bank facility.
14. If it comes to the knowledge of Govt. of NCT of Delhi that the NOC has obtained by giving any false or misleading information or by concealing or suppressing any material facts or information, the NOC granted shall be withdrawn/cancelled.
15. The University may monitor compliance of the terms & conditions on a quarterly basis. If it is found during the course of monitoring of the compliance of the terms & conditions of grant of NOC, that the institute has not complied with these terms & conditions, the University may impose stiff penalty on the institute after following proper legal procedures.
16. The NOC is subject to the Para 3.1.1 of UGC Notification dated 13.02.2012 which has been taken up by the University for relaxation.
17. The University may ensure the space norms prescribed by the Statutory Authority are complied with.
