Academic Session 2017-2018

Note This report comprises three parts: Part I deals with parameters relating to physical infrastructure of an institute. Part II evaluates several parameters that concern academics standards & infrastructure of an institute. Part III deals with the efforts made by the institute in complying with the terms and conditions of grant of NOC of the Government of NCT of Delhi, academic audit report and affiliation of GGSIPU during the year 2015-2016.

Name of the Institute: TVS

The members of JAC visited the Institute on 17 June 2017 at 10:30 am. The team interacted with the Principal and the Faculty members extensively. The JAC also went through the physical infrastructure such as classrooms, labs, library computer centre, common room, auditorium, canteen etc and based on our assessment the Institute has been awarded marks as per IP University's guidelines. The Institute must make efforts in the following areas of physical and academic infrastructure to be able to improve its grading. Following areas are recommended for improvement:

- (i) The Institute must strengthen the library by procuring books on curriculum and core curriculum areas especially the supplementary textual material from NCERT/NBT.
- (ii) Video programs produced by NCERT/CEC and IGNOU by eminent educationist must be procured.
- (iii) Faculty vehicles must be equipped with PCs/laptops given to each.
- (iv) Salary and allowances must be paid to faculty as per UAC guidelines.
- (v) Auditorium needed to audited from fire safety point of view.
- (vi) Indoor games must be introduced.
- (vii) Clean/Hygienic and affordable canteen should be provided.
- (viii) Undertaking for starting BA(Hons) Eco course must be taken for recruitment of qualified faculty and strengthening of Economic Library as per IP Univ's norms.
- (ix) Statistical Software for BA(Hons) Eco as per the course requirement.

GUIDELINES FOR THE JAC MEMBERS

PART ONE

For calculating the marks to be awarded for Cadre Ratio(CR):

Legend:

Senior Faculty (SF) = Professors + Associate Professors

Junior Faculty (JF) = Assistant Professors

CR = Cadre Ratio as defined by the AICTE / other bodies

TS = Teacher Student Ratio as defined by the AICTE / other bodies

n = No. of Divisions approved

S = Division X (No. of years of duration of the course)

$K = \frac{(S \times n)}{TS}$ = Total Teaching Faculty Required as per the Norms

f = Cadre Ratio Factor = $\frac{\{(K) - (SF \text{ actually in position})\}}{SF \text{ actually in position}}$

t = Teacher Student Ratio Factor = $\frac{(S \times n)}{(SF+JF)}$

For example: In an institute, having only ONE sanctioned Division (60 students) of B.Tech (duration 4 years), if the SF+JF is 16 (ideal), the $t = \frac{60 \times 4}{16} = 15$

But if the same institute has SF+JF=14, say, then $t = \frac{240}{14} = 17$ (say) and so on.

Case I : Where required Cadre Ratio is 1:2:6

This is applicable to the Undergraduate Courses, as per the latest AICTE Gazette Notification wherein one division has been defined as an annual intake of 60 students. This means that one division of a UG course of 4 years duration must have $S=60 \times 4=240$ students.

As per the AICTE norms, for UG courses the Cadre Ratio should be ordinarily 1:2:6, where 1 is Professor, 2 are Associate Professors and 6 are Assistant Professors.

We have defined Senior Faculty=Professors+Associate Professors

Hence the Ideal Cadre Ratio Factor 'f'=(Senior Faculty :Junior Faculty)= 1:2

For example, in an institute having only one division (60 students) of B.Tech, the total required faculty will be 16 (S=240 divided by 15) and out of this there should be ordinarily P= $\frac{S}{15 \times 9} = 2$ say (out of which 1 will be the Director/Principal)

Associate Professors=04

Assistant Professors=10

Where the CR factor 'f' = $\frac{16 \times n - (\text{Senior Faculty Actually in Position})}{\text{Senior Faculty Actually in Position}}$

Where n= No. of Divisions approved and running in the institute=.

Now suppose an institute is the worst case scenario, i.e., it has only ONE Professor (Director) and ONE Associate Professor, then it MUST have 14 Assistant Professor as per the AICTE guidelines to complete the required strength of 16 teachers(14=16 minus the total of Senior Faculty).

But if (the worst case permitted), an institute has ONE Professor and ONE Associate Professor (total=2), the $f=(16-2) \div 2=7$

Therefore in the worst case scenario, f=7.

Accordingly, the formula to award marks is:

$$\text{Awarded Marks} = 50 + 10(7-f)$$

Therefore Awarded Marks for the worst case permitted= $50 + 10(7-f) = 50 + 10(7-7) = 50 + 00 = 50$

But suppose an institute has ONE Professor and TWO Associate Professors (or, 2 Professors and one Associate Professor), then its $f=(16-3) \div 3=13 \div 3=4.333$

Therefore Awarded Marks= $50 + 10(7-f)=50+10(7-4.33)=50+10 \times 2.67=77$ say

Had this institute 2 Professors, 4 Associate Professors, then its $f=10 \div 6=1.66$ (Ideal Case)

Therefore Awarded Marks= $50 + 10(7-f)=50+10 \times (7 - 1.66) = (50 + 10 \times 5.34) = 50 + 53.4 = 100$ (maximum allowed)

And so on.

Case II: Where the required Cadre Ratio is 1:2 (M. Tech., M. Pharma, HMCT (PG))

For these courses, no relaxation will be allowed either in the required Cadre Ratio or the require Teacher Student Ratio. This means that the Institute will have to comply with the requirements as laid down by the AICTE / other statutory bodies / Govt., etc completely and fully.

PART TWO

For calculating the marks to be awarded for Teacher Students (TS) Ratio

Case One

Where the Required TS ratio is 1:20, the worst TS ratio acceptable will be 1:25

And the Awarded Marks will be as per the formula given below:

$$\text{Awarded Marks for TS ratio} = 50 + 10(25-t)$$

Where the t = Actual TS ratio factor available in an institute.

For example, for an institute having Actual TS ratio 1:20, $t=20$, and the Awarded marks $= 50 + 10(25-20) = 50 + 50 = 100$

For an institute having TS Actual TS ratio 1:21, $t=21$, and the Awarded marks $= 50 + 10(25-21) = 50 + 40 = 90$, and so on

However, the moment the term within the parenthesis $(25-t)$ becomes negative, the marks awarded will be zero, for example, for an institute having Actual TS ratio 1:26, $t=26$, the value the Marks Awarded WILL BE ZERO

Case Two

Where the Required TS ratio is 1:15, the worst TS ratio acceptable will be 1:20

And the Awarded Marks will be as per the formula given below:

$$\text{Awarded Marks for TS ratio} = 50 + 10(20-t)$$

Where t = Actual TS ratio factor available in an institute.

For example, for an institute having Actual TS ratio 1:15, $t=15$, and the Awarded marks $= 50 + 10(20-15) = 50 + 50 = 100$

For an institute having TS Actual TS ratio 1:16, then $t=16$, and the Awarded marks $= 50 + 10(20-16) = 50 + 40 = 90$ and so on

But for an institute having Actual TS ratio 1:21, $t=21$, and the Marks Awarded WILL BE ZERO, as explained earlier.

Case Three

Where the Required TS ratio is 1:12, the worst TS ratio acceptable will be 1:15

And the Awarded Marks will be as per the formula given below:

$$\text{Awarded Marks for TS ratio} = 50 + 16.67(15-t)$$

But for an institute having Actual TS ratio 1:16, $t=16$, and the Marks Awarded WILL BE ZERO

Case Four

Where the Required TS ratio is 1:10, the worst TS ratio acceptable will be 1:12

And the Awarded Marks will be as per the formula given below:

$$\text{Awarded Marks for TS ratio} = 50 + 25(12-t)$$

But for an institute having Actual TS ratio 1:13, $t=13$, and the Awarded WILL BE ZERO

Calculations for Case 3 & Case 4 are self-explanatory on the pattern stated for Case One & Two

Any institute not obtaining at least 75% for 'A' Category and 65 % for 'B' Category in Part III shall be placed in the immediate succeeding category.

VERY IMPORTANT NOTE:

- A. The above calculation has been done keeping in view the requirement of Teachers for the complete duration of the course. However, in cases where new programme has been started or to be started or for programmes where atleast one batch of students has not passed out, the requirement of teachers shall be calculated proportionately.
- B. Any institute not obtaining at least 75% for 'A' Category and 65% for 'B' Category in Part III shall be placed in the immediate succeeding category.
